

A General Plan Update (GP) and for input on a Community development Block Grant (CDBG) activities.

- 1. General Plan Update includes Land Use Inventory: a parcel by parcel land use survey of the City of Guadalupe area, Regional Visioning: seek information on visions for neighboring communities in the county to create a synthesis of a regional vision within which the City of Guadalupe will play a role and Community Visioning Meeting: This meeting will also serve as a forum for defining and fine-tuning emerging directions gathered from community and other sources toward a Community Vision.
- 2. CDBG Eligible Activities allowed are Economic Development, Public Service, Public Facilities, Planning & Technical Assistance, and Housing Programs. The City plans include a resubmittal of a Leroy Park/Boy & Girls facility rehab under Public Facilities. One additional activity can be submitted, please help us determine what the City needs.
