GENERAL INFORMATION

1. All types of handicrafts, art, photography, sculpture and jewelry are acceptable.
2. You must provide your own tables and chairs. Each vendor is responsible for own set-up.
3. All tents must be weighted.
4. You must provide your own trash can liners.
5. Decorate your booth in a festive manner.
6. Booths must be manned between 5:00 pm and 8:00 pm. Please have all vehicles removed from booth area no later than 4:30 PM.
7. All display stands, tables, racks, shelves, etc., must be kept within the marked boundaries of each vendor's space.
8. All items must be priced. Vendor must supply bags or wrappings and a receipt for all purchases. Collection of State sales tax is the responsibility of each vendor.
9. Each vendor must check in early for their space assignment.
10. Vendor parking is available behind the parking lot off Olivera Street.
11. Vendor spaces are limited. Reserve your space early.
12. **FOOD VENDORS:** Are required to complete the Santa Barbara County Health Department Permit Application, two weeks prior to event.
13. **There is limited amount of Electrical Power available and you may need to provide your own portable generator.**
