#### **MINUTES**

# CITY OF GUADALUPE REGULAR MEETING OF THE RECREATION AND PARKS COMMISSSION WEDNESDAY, February 12, 2020

Call to Order: Recreation Coordinator Guzman called the meeting to order at 6:00 pm.

Recreation Coordinator Guzman noted the Commissioner Attendance as Follows:

Commissioner Enrique Ortiz- present Commissioner Open Position Commissioner Gilbert Robles – absent Commissioner Joseph Harris – present Commissioner Tommy Solis Jr- present

<u>Pledge of Allegiance:</u> Commission Chair Joe Harris was recognized and led the Commission in the pledge of allegiance.

Community Participation Forum: Chair Harris opened the Community Participation Forum by recognizing Shannon Sweeney, City of Guadalupe Public Works Director. Shannon spoke in reference to request from the Pasadera neighborhood residents seeking to establish a Dog Park preferably in the Jack O'Connell Park area. Shannon also indicated that the Dog park was a great idea for canine lovers throughout the City and recommended further investigation on the feasibility of creating a Dog Park or user friendly area dedicated to this idea.

There were no other requests to speak so the forum closed at 6:14 PM.

#### **Regular Business:**

- After some discussion the Commission voted unanimously to accept the resignation of Commissioner Gerard Almaguer based upon a motion by Commissioner Ortiz and a second from Commission Chair Harris. The Commission as a whole wished Gerard well and hoped that he could still be an active community supporter into the future when he is able.
- 2. The Recreation Coordinator Charlie Guzman updated the Commission on the progress of the City Hall Auditorium floor renovation that has been scheduled to commence later this month. The City awarded the renovation / refinishing contract work to the Pacific Floor Company. Pacific Floor Company in addition to being the lowest bid, has a great reputation for the great quality of their work throughout the local high school

communities. Pacific Floor Company also has extensive experience working throughout the Southern California with many of the college and professional arenas. Our City of Guadalupe Public Works Director -Shannon Sweeney also spoke on the bid process and specifically on the work contracted. The Commissioners voiced the pleasure on the on the swiftness and attention that the City Staff has demonstrated on getting the work accomplished.

- 3. The Commission was also updated on the status of the City's ongoing lease agreement renewal with the American Legion for the use of the Veterans Memorial building. Shannon Sweeney reported that the lease agreement draft was in tis final stages and hoped to have additional discussions with the American Legion Board of directors once the lease draft agreement is completed and ready for presentation to the American Legion. The Commission was pleased by the way City Staff was proceeding with the Veterans Building lease agreement negotiations.
- 4. The Commission had a spirited discussion on the City's options for the continued use of the Downtown Parking Lot's Electric Charging station. Staff (Charlie Guzman) gave a brief history on how the City acquired the Electric Station and the City's responsibilities with respect to the Electric Station maintenance. Shannon Sweeney noted that the Station is operable but used infrequently as far as she knew. The Commission voted unanimously to recommend to the City Council to continue to provide this positive electrical service in the downtown location a long as it is fiscally feasible. This motion was made by Commissioner Solis and seconded by Commission Chair Harris.
- 5. Staff (Charlie Guzman) reviewed the new recommended City Facility Use Fee schedule with the Commissioners. After some clarification, concerns and discussion about the fiscal impact on the city's Non-Profits and community youth groups. The Commission again voted unanimously based upon a motion by Commission Chair Harris and seconded by Commissioner Ortiz that the City Council approve and adopt the new Fee Schedule as written.
- 6. The Commission reviewed and discussed with staff (Charlie Guzman and Shannon Sweeney) the current fiscal year Recreation and Parks budget report provided by staff covering the period through December 2109. There were no questions or motions at this point with respect to the budget.
- 7. The Commission also discussed the practical use and idea of a user- friendly area designated for a Dog Park per the suggestion presented during the Community Participation Forum. The Commission based upon a motion from Commissioner Solis and seconded by Commissioner Ortiz voted unanimously to recommend to the City

Council that staff be directed to investigate the feasibility of a designated user-friendly Dog park area at Jack O'Connell Park.

Staff Request and Announcements: Recreation Coordinator Guzman, in addition to the fee schedule information noted that he has been in contact with the various groups (local designated youth groups and Non-Profits) about the possibility of City facility fee schedule changes that could impact them and their use of City facilities. Recreation Coordinator Guzman also provided the Commission with an informational sample copy of the City of Santa Maria Facility and Parks current facility fee schedule. Along with the January 2020 Recreation and Parks monthly report presented to the City Council.

**Commission Requests, Comments and Meeting Reports:** Other than the recommended continued use of the Electric Charging Station located at the Downtown Parking Lot and Designated Dog Park area request as City Council future agenda items, there were no other requests.

**Future Agenda Items-** It was the consensus of the Commission also wished to continue the discussion on the City's current lease agreement resolution with regards to the City owned Vets Hall and the American Legion Post 371. There was also a request form Commissioner Ortiz to discuss the replacement of the football scoreboard located at Jack O'Connell Park since it is no longer working and there are no replacement parts available for its repair.

**Adjournment:** A motion was made by Commissioner Solis with a second by Commissioner Ortiz to adjourn the meeting. The meeting was adjourned at 8:04PM.
